

RESOLUTION 2022-04

**A RESOLUTION OF THE UPPER MONTGOMERY JOINT AUTHORITY,
MONTGOMERY COUNTY, PENNSYLVANIA,
AUTHORIZING THE EXECUTIVE DIRECTOR TO REQUEST A STATEWIDE
LOCAL SHARE ASSESSMENT GRANT FOR IMPROVEMENTS TO THE SLUDGE
TRANSFER PUMPS, LEVEL SENSORS, RECONSTRUCTION OF CLARIFIER T-5B
AND UPGRADE OF SECURITY CAMERAS AND LOCKS AT THE WASTEWATER
TREATMENT PLANT**

WHEREAS, Upper Montgomery Joint Authority (hereinafter “UMJA”) is a municipal authority organized and existing under the Pennsylvania Municipality Authorities Act of 1945, as amended; and

WHEREAS, UMJA has constructed, owns, and operates sanitary sewage collection and treatment facilities in East Greenville, Pennsburg, and Red Hill Boroughs, and a portion of Upper Hanover Township, Montgomery County, Commonwealth of Pennsylvania; and

WHEREAS, the Board of Directors desires to seek a Statewide Local Share Assessment Grant (hereinafter referred to as the “Grant”) for improvements to the Wastewater Treatment Plant (hereinafter referred to as the “Plant”) that include upgrading the Primary Sludge Transfer Pumps, Installation of new Sludge Blanket Level Sensors, Reconstruction of the Final Clarifier T-5B; and upgrading the security at the Plant; and

WHEREAS, the Board of Directors directs the Executive Superintendent and the Authority’s Engineering to make application for such Grant and to execute all documents and agreements necessary or required to facilitate obtaining said Grant; and

WHEREAS, the Authority’s Engineer has prepared an estimate of construction cost for the work proposed to be completed under the Grant in the sum of One Hundred Forty Nine Thousand Nine Hundred Fifty Two & 13/100 (\$149,952.13) Dollars;

NOW THEREFORE, be it **RESOLVED**, and it is hereby **RESOLVED** that the Board of Directors the following:

1. Jennifer Leister, Executive Superintendent, is authorized on behalf of the Authority to make application for the Grant in the sum of One Hundred Forty Nine Thousand Nine Hundred Fifty Two & 13/100 (\$149,952.13) Dollars and to execute all documents required or necessary to facilitate the application for, and acceptance of said Grant.

2. The Authority's Engineer is authorized to assist the Executive Superintendent to make application for said Grant by preparing documents, cost estimates, drawings, specifications and other necessary engineering products as requested by the Executive Superintendent.
