A RESOLUTION OF THE UPPER MONTGOMERY JOINT AUTHORITY, MONTGOMERY COUNTY, PENNSYLVANIA, MODIFYING THE RATES CHARGED FOR PUBLIC SEWER PROVIDED BY THE UPPER MONTGOMERY JOINT AUTHORITY; PROVIDING FOR THE REPEAL OF INCONSISTENT AND CONFLICTING RESOLUTIONS; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, Upper Montgomery Joint Authority (hereinafter "UMJA") is a municipal authority organized and existing under the Pennsylvania Municipality Authorities Act of 1945, as amended; and

WHEREAS, UMJA has constructed, owns, and operates sanitary sewage collection and treatment facilities in East Greenville, Pennsburg, and Red Hill Boroughs, and a portion of Upper Hanover Township, Montgomery County, Commonwealth of Pennsylvania; and

WHEREAS, UMJA desires to update its fee schedule and modify the rates charged to its customers effective June 1, 2023;

NOW THEREFORE, be it RESOLVED, and it is hereby RESOLVED that the Authority adopts new Fee Schedule and the Sewer Rental Billing Rates as follows:

- 1. <u>Fee Schedule for 2023</u>. The authority hereby adopts the Fee Schedule and Sewer Rental Billing Rates to be charged by the Upper Montgomery Joint Authority which is attached hereto and incorporated herein as **Exhibit 'A.'**
- 2. <u>Repealer</u>. All prior Resolutions or parts of Resolutions, and any parts of the Rules, Rates, and Regulations, insofar as they are inconsistent herewith, are hereby repealed.
 - 2. <u>Effective Date</u>. This Resolution shall be effective on June 1, 2023.
