Non-Emergency Sewer Line Replacement & Repair

- Notify the borough or township and obtain necessary permits.
- Call the PA ONE Call system AT 1-800-242-1776 Before you dig.
- Do not begin work until Permits have been issued (Except for Emergency Repairs)
- Trenches **must** remain open to be inspected. Any work covered will be required to be exposed for inspection.
- UMJA must re-inspect the repair work, and the re-inspection fee is **\$225.00**. If repair work is from a **PA1 Call**, this fee will be billed to the contractor doing the work.

Emergency Sewer Line Replacement & Repair

- Any work to be done after hours as an emergency will require a permit application the following business day.
- Trenches **must** remain open to be inspected; proper plating or safeguarding of the work area is required.
- Any work covered will be exposed for inspection.
- UMJA must re-inspect the repair work, and the re-inspection fee is **\$225.00**. If repair work is from a **PA1 Call**, this fee will be billed to the contractor doing the work.

All inspections must be completed Monday- Friday between the hours of 7:30 AM – 3PM
